#### Processing:

WACKER® FINISH WT 1650 LV can be applied neat, from solution or emulsion. Suitable solvents are aliphatic and aromatic

hydrocarbons, chlorinated hydrocarbons, esters, higher alcohols and ketones.

Most textile processes are water based. Hence WACKER® FINISH WT 1650 LV is mainly applied from emulsion. WACKER ® FINISH WT 1650 LV is suitable for the formulation of microemulsions and macroemulsions.

WACKER® FINISH WT 1650 LV can be used as sole active substance in softener emulsions or in combination with other components, e.g. paraffines, esters of fatty acids, etc. Compatability of the components has to be checked in each individual case.

Emulsions of WACKER® FINISH WT 1650 LV LV are diluted to the optimum concentration for the specific fabric. Application can be done by padding or exhaustion.

#### Storage

Store in a cool dry place.
